Education

B.A. Honors and M.A. in Economics at the University of Dhaka. First class in both. Was placed first in order of merit in M.A. examination (1959) for which received a special Presidential Award.

Ph.D. in Economics at Cambridge University, 1966. Thesis on "A Multisectoral Programming Model for Regional Planning in Pakistan" written under the supervision of James A. Mirrlees, 1996 Nobel Laureate in Economic Sciences.

Interest and Specialization

Work experience includes (i) teaching, (ii) research, (iii) economic policy work for governments in developing countries; and (iv) policy and research work in international development agencies.

Research work can be broadly classified into three main areas: (i) Macro and micro level planning: work in this area consists of both economy-wide planning models (ranging from the construction of input-output tables and using them to prepare multi-sectoral models for both consistent and optimum planning) and methods of project evaluation (especially the formulation of a model of estimating accounting prices for project evaluation). (ii) Problems of employment, income distribution and poverty: work in these areas has consisted of the analysis of employment, income distribution and poverty trends in developing countries (principally in Asia including Central Asia but also in several African Countries) and formulating policies to promote employment, improve the distribution of income and alleviate poverty. (iii) Problems of post-

socialist transition: work in this area has focused on transitional problems of inequality, poverty and unemployment; agrarian institutions; and systemic change in economic organization. (iv) Agrarian Systems: work under this subject includes comparative analysis of different agrarian systems from the standpoint of efficiency, equity and poverty reduction; analysis of land reform.

Combines experience in policy work both in the developing countries and in international development agencies. Organized the technical work, including the formulation of a multisectoral model that served as the methodological frame, for the First Five-Year Plan of Bangladesh. Carried out similar work during the preparation of the Fourth Five-Year Plan of Pakistan and the Second Five-Year Plan of Bangladesh. Developed a system of project appraisal for the Bangladesh Government.

As a staff member of international development agencies such as the World Bank and the International Labor Organization and as a consultant to the United Nations Development Program, the Organization for Economic Cooperation and Development, the UNCTAD, the IFAD, carried out research/advisory work in a large number of developing countries. Was involved in field work in Bangladesh, Pakistan, India, Egypt, Uzbekistan, Tajikistan, Kazakhstan, Kyrgyz Republic, Russia, Thailand, Indonesia, Philippines, Sri Lanka, Nepal, Laos, China, Vietnam, Poland, Liberia, Nigeria, Ethiopia, Kenya and Uganda.
